How to export a product in Tunisia without authorization?

Exports in firm sales with payment of an amount exceeding 200 Tunisian dinars, in respect of products benefiting from the regime of freedom to export, are made without authorization under cover of a definitive invoice domiciled with an approved intermediary, in accordance with the conditions provided by the Central Bank of Tunisia.

What is the VAT rate in Tunisia?

The standard VAT rate in Tunisia is 19%, but there are reduced rates for certain essential items. Import duties are aligned with Tunisia's economic protection strategies and may range from 0% to higher rates depending on the goods' classification.
